WHEREAS, under Section 16 of Republic Act No. 7160 (Local Government Code of 1991), local government units are empowered to promote the general welfare of their constituents through public service initiatives, including education.

WHEREAS, the Municipality of Bustos, through Kapasiyahan Blg. 2023-02, allocated Four Million Pesos (₱4,000,000.00) for the acquisition of land to establish Tanawan Elementary School, addressing the urgent need for educational infrastructure in Barangay Tanawan;

WHEREAS, the Municipality currently owns a parcel of land in Barangay Tanawan, identified as TCT No. 039-2013000517, with an area of 2,200 square meters, which is suitable and strategically located for the school's construction;

WHEREAS, donating the said property to the DepEd aligns with the municipality's commitment to advancing public education, optimizes the use of public funds under Kapasiyahan Blg. 2023-02, and complies with the provisions of RA 7160, allowing donations for educational purposes;

WHEREAS, under Section 444(b)(1)(vi) of RA 7160, the Municipal Mayor is authorized to represent the local government unit in transactions, subject to Sangguniang Bayan approval.



APPROVED and ADOPTED, 7th day of April, 2025 by the Sangguniang Bayan at the Amado Raymundo Session Hall.




