“REORGANIZING AND CONSTITUTING THE HUMAN RESOURCE MERIT PROMOTION AND SELECTION BOARD (HRMPSB) OF THE MUNICIPAL GOVERNMENT OF BUSTOS, BULACAN, PURSUANT TO THE 2017 OMNIBUS RULES ON APPOINTMENT AND OTHER HUMAN RESOURCE ACTIONS (ORAOHRA).”

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides for the creation of a Personnel Selection Board (PSB) to assist in the appointment or promotion of personnel in the Municipal Government and in the formulation, development, and implementation of policies that contribute to the welfare of municipal employees;

WHEREAS, the Code likewise mandates the creation, reorganization, and reconstitution of the Personnel Selection Board (PSB) in every province, city, and municipality, prescribing its composition, organization, and functions;

WHEREAS, in consonance with Civil Service Commission Memorandum Circular No. 3, Series of 2001, defines the composition of the Personnel Selection Board (PSB);

WHEREAS, on September 22, 2022, the Bustos Employees Association conducted an election for a new set of officers, duly officiated by the Human Resource Management Office, and proclaimed on September 23, 2022 during its General Assembly;

WHEREAS, Civil Service Commission Resolution No. 1701008, which took effect on August 17, 2017, promulgated the 2017 Omnibus


Rules on Appointment and Other Human Resource Actions (ORAOHRA), applicable to employees in first and second-level positions, including executive/managerial positions that are not presidential appointees in the career service, as well as those in the non-career service;


WHEREAS, said resolution mandates the constitution of a Human Resource Merit Promotion and Selection Board (HRMPSB), which shall serve as the recommending body for appointments;


THEREFORE, upon motion by HONORABLE ROMEO B. CABALQUINTO, and unanimously agreed upon by all the members present.
