WHEREAS, the Local Government Code of 1991 (Republic Act No. 7160) grants authority to municipal governments in various aspects, including the recruitment and selection of police personnel;

WHEREAS, the National Police Commission (NAPOLCOM) Memorandum Circular No. 2021-001, issued on April 8, 2021, provides the guidelines and procedures for the recruitment, selection, and appointment of Patrolmen and Patrolwomen, which the Committee must strictly adhere to in its operations;

WHEREAS, Section IV.2 of the aforementioned NAPOLCOM memorandum circular mandates the formation of a screening committee at the municipal level to screen, evaluate, and recommend qualified applicants to the Philippine National Police (PNP);

WHEREAS, it is crucial to establish a local screening committee to efficiently manage the recruitment process and ensure that only the most qualified candidates are considered for the PNP recruitment program;

WHEREAS, ensuring transparency, fairness, and accountability in the recruitment process is essential to uphold the integrity of the PNP and to build public trust in law enforcement.

THEREFORE, upon motion by **HONORABLE RAYMOND R. PEREZ**, and unanimously agreed upon by all the members present.
