WHEREAS, Section 14 of Philippine National Police (PNP) Reform and Reorganization Act of 1998 (Republic Act No. 8551) provide for the minimum requirements for appointment into the PNP service;

WHEREAS, on May 26, 2021, Philippine National Police, Bureau of Fire Protection, Bureau of Jail Management and Penology, and Bureau of Corrections Height Equality Act (Republic Act No. 11549) was passed, lowering the minimum height requirement for appointment as officer or member of the PNP to 1.57m for males and 1.52m for females;

WHEREAS, on April 8, 2021, the National Police Commission (NAPOLCOM) issued Memorandum Circular No. 2021-001 entitled "Prescribing the Guidelines and Procedures for the Recruitment, Selection and Appointment of Patrolman/Patrolwoman";

WHEREAS, the Ad Hoc Body shall convene to conduct an initial screening and preliminary interview of individual applicants to determine their residency status; completeness of documents submitted; establish whether the applicant meets the age, height, weight, education and eligibility requirements; determine his/her potential and worthiness to be appointed as law enforcer; and personal appearance and conversational ability;

WHEREAS, on October 1, 2025, the NAPOLCOM issued Resolution No. 2025-0580 entitled "Granting the Chief PNP the authority to recruit Six Thousand and Five Hundred Eighty-Nine (6,589) attrition quota for Patrolman/Patrolwoman for the Calendar Year (CY) 2025 Recruitment Program", wherein PRO3 was allocated a total quota of Five Hundred Fifty (550);

WHEREAS, the Ad Hoc committee after assessing the application documents, submitted to the body found the in order and worthy of recommendation.

THEREFORE, upon motion by **HONORABLE RAYMOND R. PEREZ**, and unanimously agreed upon by all the members present.


