WHEREAS, the Executive Committee (EXECOM) adopted EXECOM Resolution No. 2025-01 entitled “Kapasyahang Nagpapatibay sa Paghiling ng Karagdagang Pondo para sa Comprehensive Land Use Plan na Nagkakahalaga ng Limang Daang Libong Piso (PhP 500,000.00)” which seeks an additional budget requirement for the preparation of the Comprehensive Land Use Plan (CLUP) of the Municipality of Bustos for CY 2025-2031;

WHEREAS, the formulation and updating of the Comprehensive Land Use Plan (CLUP) is a mandatory function of all Local Government Units pursuant to Republic Act No. 7160 or the Local Government Code of 1991, the National Urban Development and Housing Framework (NUDHF), and the guidelines of the Department of Human Settlements and Urban Development (DHSUD);

WHEREAS, the Municipal Planning and Development Office (MPDO) emphasized the need to augment the existing CLUP budget due to additional technical requirements, data processing activities, and sectoral analyses necessary to complete the CLUP updating;

WHEREAS, the Community-Based Monitoring System (CBMS) Program for FY 2025 has available funds that will no longer be fully utilized and may be realigned or augmented in accordance with Section 336 of the Local Government Code, allowing the reversion and reallocation of unobligated appropriations;




THEREFORE, upon motion by **HONORABLE ALJHANEAL E. QUIÑONES,** and unanimously agreed upon by all the members present.


